FLRA PROVIDES NOTICE OF PUBLICATION OF BOUND VOLUME NO. 69

The Federal Labor Relations Authority (FLRA) is pleased to announce that it has prepared for publication by the Government Printing Office (GPO) its 69th bound volume of Authority decisions. *Decisions of the Federal Labor Relations Authority, Volume 69*, will include decisions that issued from October 1, 2015, to September 30, 2016. Providing the opportunity to purchase bound volumes is yet another way that the FLRA makes Authority case law available to its customers. And Authority decisions, decisions of the Authority's Office of Administrative Law Judges, and decisions of the Federal Service Impasses Panel are available at no charge – and in searchable format – soon after issuance at www.flra.gov/decisions.

The bound volume may be obtained by federal agencies on a pro-rated cost basis by “riding” the FLRA Requisition Number listed below. Agency rider requisitions ([Standard Form 1](#)) should be submitted to GPO no later than **Friday, November 18, 2016**. The preferred method of submitting an SF-1 is to email the form to requisition@gpo.gov with “GPO Jacket No. 395-970” in the Subject line. GPO will also accept SF-1s by fax at (202) 478-1762, or by mail at Agency Procurement Services, COMSTAT, Stop CSA, U.S. Government Publishing Office, 732 N. Capitol Street, NW, Washington, DC 20401. Agencies are urged to submit requisitions to GPO because the Superintendent of Documents will not stock large quantities of the publications, and the publications will not be available for purchase from the FLRA.
