DECISION AND ORDER

REMANDING CASE TO THE REGIONAL DIRECTOR

On May 11, 2001, the complaint in the subject case was reinstated and remanded by the Federal Labor Relations Authority (Authority) to the Chief Administrative Law Judge for further processing consistent with its decision. Pursuant to the Authority's Order a hearing was scheduled in this matter for October 18, 2001.

On October 4, 2001, the Regional Director for the Dallas Regional Office informed the Chief Administrative Law

that the matter had settled and requested it be remanded for appropriate processing.

Accordingly, the matter is remanded to the Regional Director, Dallas Regional Office to take whatever action deemed necessary in order to effectuate the purposes and policies of the Statute.
