FLRA PROVIDES NOTICE OF PUBLICATION OF BOUND VOLUME NO. 67 AND THE “POCKET STATUTE,” FLRA DOC. NO. 1071A

The Federal Labor Relations Authority (FLRA) is pleased to announce that it has prepared for publication by the Government Printing Office (GPO) its 67th bound volume of Authority decisions. *Decisions of the Federal Labor Relations Authority, Volume 67*, will include decisions that issued from October 1, 2012, to September 30, 2014. Providing the opportunity to purchase bound volumes is yet another way that the FLRA makes Authority case law available to its customers. And Authority decisions, decisions of the Authority’s Office of Administrative Law Judges, and decisions of the Federal Service Impasses Panel are available at no charge – and in searchable format – soon after issuance at www.flra.gov/decisions.

In addition, the FLRA has prepared for publication by GPO – and for purchase by other federal agencies – the “Pocket Statute,” which is the 3” x 5” soft-bound, pocket-sized version of the Federal Service Labor-Management Relations Statute and the Back Pay Act. As the FLRA’s website provides a printable version of the Pocket Statute at www.flra.gov/statute, the FLRA no longer distributes copies of the Pocket Statute to its customers. But the FLRA is pleased to again offer its customers the opportunity to purchase this popular publication in bulk directly from GPO for a limited time.

Both publications may be obtained by federal agencies on a pro-rated cost basis by “riding” the FLRA Requisition Numbers listed below. Agency rider requisitions ([Standard Form 1](#)) should be submitted to GPO no later than **Friday, November 7, 2014**. Agencies are urged to submit requisitions to GPO because the Superintendent of Documents will not stock large quantities of the publications, and the publications will not be available for purchase from the FLRA. Other organizations and individuals may order the publications directly from the Superintendent of Documents, GPO, when they become available. GPO may be reached at: (202) 512-1800. In addition, some earlier volumes of *Decisions of the Federal Labor Relations Authority* remain available for purchase through GPO’s Bookstore at: <http://bookstore.gpo.gov>, and both Volume 67 and the Pocket Statute will be stocked there until supplies run out.
