Minute of Panel Action

November 25, 2019

On November 12, 2019, President Donald J. Trump issued a Memorandum for the Federal Labor Relations Authority ("FLRA"). In that memorandum, he concurrently delegated to the FLRA the power under 5 U.S.C. 7119(c)(3) to remove the Chairman of the Federal Service Impasses Panel ("Panel") and any member of the Panel appointed by the President under 5 U.S.C. 7119(c)(2).

By its express terms, the President's memorandum was not intended to create any new rights or benefits. Nonetheless, out of an abundance of caution, and in view of ongoing and potential litigation and the need to remove any question regarding the validity of its orders, the Panel now confirms, adopts and ratifies nunc pro tunc the following orders:

Dear Mr. Carter,

This is in response to your request that Federal Service Impasses Panel (Panel) members review the Panel's jurisdictional rulings as well as Decisions and Orders beginning in 2017 as specified in the Panel Minute dated November 25, 2019 (attached). I have carefully reviewed each of these cases and respond as follows:

- 1. With regard to the Panel Decisions and Orders in case numbers 18 FSIP 081 and 19 FSIP 038, during the period 2011 until 2016, I was Intermittently employed (there were gaps in the negotiations lasting for up to a year) as the Chief Negotiator for the renegotiation of an expired agreement at the Pension Benefit Guarantee Corporation. I also provided technical assistance and training in labor relations for the Agency during this period. I recall providing advice on the case addressing the office move and while I do not recall advising on the other matter, I cannot rule out that I may have answered questions related to those negotiations. Therefore, I believe an appearance of a conflict of interest may be perceived by my concurrence with the Panel determinations in these two cases and recuse myself from voting on these cases.
- 2. Regarding the Decisions and Orders other than those addressed in Number 1. and specified in the Panel Minute of November 25, 2019, above, I concur with the Panel determinations.
- 3. With regard to Jurisdictional determination in case numbers 18 FSIP 037 and 18 FSIP 045, I was employed during the time period of the matter before the Panel as the Chief Negotiator for the Northeast region of the U.S. National Park Service. While I had no direct involvement in these cases, I believe an appearance of a conflict of interest may be perceived since the Park in question falls within the management authority of the Northeast region. Therefore, I believe an appearance of a conflict of interest may be perceived by my concurrence with the Panel determinations and recuse myself from voting on these two cases.
- Regarding the jurisdictional determinations in the cases other than those addressed in Number
 and specified in the Panel Minute of November 25, 2019, above, I concur with the Panel determinations.
